IN 2021 EDUCATIONAL VISITS WERE BACK TO THE PRE-PANDEMIC COVID-19 STAGE FOR THE MAJORITY OF THE YEAR. THERE WERE STILL SOME CANCELLATIONS AND WE KEPT THE GROUP SIZES AT 12 COMPARED TO 15 PEOPLE. AN ESTIMATED 5000 PEOPLE VISITED THE SANCTUARY IN DIFFERENT PROGRAMS IN 2021. EDUCATION STAFF DID VIRTUAL PRESENTATIONS ONLINE TO REACH AS MANY MORE PEOPLE AS POSSIBLE AND SAW AN INCREASE IN COMMUNITY EVENTS AND PRESENTATIONS COMPARED TO 2020.

THE ORGANIZATION HAS DONE VIRTUAL AND IN-PERSON PRESENTATIONS TO SCHOOLS, COMMUNITY GROUPS, LIVING FACILITIES, ENVIRONMENTAL GROUPS, AND HEALING HEARTS PARTNER ORGANIZATIONS THROUGH 2021. SHY WOLF HAS REACHED PEOPLE AROUND THE WORLD THROUGH THESE MEASURES AND OUR EXPANDED SOCIAL MEDIA PRESENCE OF OVER 200K FOLLOWERS, WHO TUNED IN FOR HAPPY PHOTOS AND VIDEOS.
